FAPAS[®] Price List

ROUND COST: Each FAPAS[®] round costs £125 except round 0616 (dioxins) which costs £550.

DISCOUNTS: Participants taking 6 or more FAPAS[®] rounds are entitled to discounts as detailed in the table below. These discounts do not apply to postage or courier charges and only apply to rounds requested in a single order.

ADDITIONAL POSTAGE COSTS: All non-European Union (non-EU) participants add an additional 4% to total round cost for mailing charges. Optional charges for sending all test materials by courier are available on request.

COURIER COSTS: Rounds marked F on the order form will be sent by courier. The charges for this service are an additional £15 for UK addresses and £50 for all other addresses.

Do NOT send payment until invoiced- once invoiced please pay in 30 days.

Cheques should be made payable to Central Science Laboratory in £ GB (paid using a cheque drawn on a UK bank), or made payable in € or \$US.

BACS payments and bank credit transfers are acceptable please see your invoice for details. Please ensure that your payment includes all bank charges incurred in transferring fees. CSL will not be liable for these charges and will aim to recover any costs incurred from participants.
